On the basis of § 2 para. 4 (1) in conjunction with § 64 of the Higher Education Act of the State of North Rhine-Westphalia (Hochschulgesetz - HG) of 16 September 2014 (GV. NRW. p. 547), last amended by the Act of 30 June 2022 (GV. NRW. p. 780b), and the Framework Examination Regulations (*Rahmenprüfungsordnung - RPO*) for the Bachelor's and Master's degree programmes at FH Aachen University of Applied Sciences of 1 February 2018 (FH-Mitteilung no. 3/2018), last amended by Amendment Regulations of 22 June 2022 (FH-Mitteilung No. 99/2022), the Faculty of Business Studies has issued the following regulations governing the cancellation of the Examination Regulations for the Bachelor's degree programmes "Global Business and Economics" and "Global Business and Economics with semester abroad" dated 10 May 2017 (FH-Mitteilung No. 49/2017), last amended by regulations dated 3 February 2022 (FH-Mitteilung No. 15/2022):

§ 1 | Subject Matter and Scope

These regulations govern the repeal of the Examination Regulations for the Bachelor's degree programmes "Global Business and Economics" and "Global Business and Economics with Semester Abroad" of 10 May 2017 (FH-Mitteilung No. 49/2017), last amended by regulations of 3 February 2022 (FH-Mitteilung No. 15/2022).

§ 2 | Range of Studies and Examinations

(1) The courses provided in accordance with the provisions of the Examination Regulations mentioned in § 1, as amended from time to time, shall be offered for the last time on the dates specified below:

Semester	Course Offered for the Last Time
1.	WS 2021/22
2.	SS 2022
3.	WS 2022/23
4.	SS 2023
5.	WS 2023/24

(2) The respective examinations shall be offered for the last time on the dates specified below:

Semester	Last Examination Date
1.	Examination Period January/February 2025
2.	Examination Period July 2025
3.	Examination Period January/February 2025
4.	Examination Period July 2025
5.	Examination Period July 2025

(3) In accordance with the Examination Regulations specified in § 1, the semester abroad of the degree programme "Global Business and Economics with semester abroad" can be completed for the last time in the summer semester of 2025.

§ 3 | Deadline for Taking the Bachelor's Examination

In accordance with the Examination Regulations specified in § 1, the practical project, Bachelor's thesis and colloquium of the degree programme "Global Business and Economics" can be taken for the last time up until 28 February 2026, and of the degree programme "Global Business and Economics with Semester Abroad" up until 31 August 2026.

§ 4 | Transitional Arrangements and Information for Students

(1) Students who have taken up their studies in the Bachelor's degree programme "Global Business and Economics" or "Global Business and Economics with Semester Abroad" for the first time from the winter semester 2022/23 onwards shall continue their studies in the degree programmes "Global Business and Economics" or "Global Business and Economics with Elective Semester" as of the winter semester 2023/24 according to the Examination Regulations for the Bachelor's degree programmes "Global Business and Economics" and "Global Business and Economics with Elective Semester" leading to the degree Bachelor of Science at the Faculty of Business Studies of FH Aachen of 11 January 2023 (FH-Mitteilung No. 1/2023) – as amended from time to time.

(2) For students who commenced their studies in the Bachelor's degree programme "Global Business and Economics" or "Global Business and Economics with semester abroad" prior to the winter semester 2022/23, the following shall apply:

Insofar as the examinations are not taken within the deadlines of §§ 2 and 3, students will lose their right of examination entry in these Examination Regulations for the respective subject or Bachelor's examination. After these deadlines have expired, students (subject to re-registration), without further application, shall continue their studies in the degree programme "Global Business and Economics" or "Global Business and Economics with Elective Semester" according to the Examination Regulations of 11 January 2023 (FH-Mitteilung No. 1/2023) – as amended from time to time.

(3) Upon application, students studying according to the Examination Regulations specified in § 1 may irrevocably switch to the Examination Regulations for the Bachelor's degree programmes "Global Business and Economics" and "Global Business and Economics with Elective Semester" leading to the degree Bachelor of Science at the Faculty of Business Studies of the FH Aachen of 11 January 2023 (FH-Mitteilung No. 1/2023) – as amended from time to time. The switch shall be possible for the first time as of the winter semester 2023/24.

(4) The details regarding the transition to the Examination Regulations for the Bachelor's degree programmes "Global Business and Economics" and "Global Business and Economics with Elective Semester" of 11 January 2023 (FH-Mitteilung No. 1/2023) – as amended from time to time – shall be regulated by resolution of the Faculty Council when required.

(5) The regulations pursuant to § 1 shall expire on 31 August 2026 and shall be repealed.

(6) The students of the Bachelor's degree programmes "Global Business and Economics" as well as "Global Business and Economics with semester abroad" pursuant to the Examination Regulations specified in § 1 shall be informed of the provisions of these Regulations by means of a displayed notice and via the web pages of the Examination Office.

§ 6 | Entry into Force, Publication

(1) These Amendment Regulations shall enter into force on the day after publication in the official gazette of FH Aachen (FH-Mitteilungen).

(2) Issued on the basis of the resolution of the Faculty Council of the Faculty of Business Studies of 3 April 2023 and the Rectorate of 19 April 2023.

Notice pursuant to § 12 para. 5 HG:

The violation of procedural or formal regulations of the Higher Education Act or of the regulatory, or other autonomous, law of FH Aachen can no longer be asserted against these regulations after the expiry of one year since their publication, unless,

- a) the regulations have not been announced in a proper manner,
- b) the Rectorate has previously objected to the resolution of the competent body, or
- c) an objection to the formal or procedural defect has been made beforehand to the university, stating the legal provision that has been violated and the fact that gives rise to the defect.
